Subject: Minutes of Open Space Committee held November 3, 2009

Attendees: Justine Kent-Uritam (Chair), Jane Brace, Carol Lisbon (Selectman Rep.), Rich Oasis, Catherine White, Christophe Oliver, Andy Thompson, Paul Angelico, Boynton Glidden.

Justine called the meeting to order at 7:50 P.M. at the Town Hall.

Upon motion duly made and seconded, the minutes of the previous meeting held on October 6, 2009 were approved unanimously.

Justine introduced Jerry Arnold who proceeded to lead a discussion on the marking of the trails and boundaries of the Wylde Woods. After much discussion, it was unanimously agreed that Jerry should proceed with the signs and markers, working with Paul and the Conservation Commission on this project.

Justine led a discussion of the Community Goals - 5 Year Action Plan. She followed this up by forwarding a revised draft of said plan to each member. We to discuss further at the next meeting.

Justine also led a discussion about the applicability of Article 97. Upon motion duly made and seconded it was unanimously voted to approve Justine's draft of article 97 as it applies to open spaces.

Justine suggested appointed various members to coordinate with other Town Boards on our Community Goals/5 Year Actio Plan. Hopefully we will have this performed by January, 2010.

Carol announced the upcoming meeting on November 12, 2009 in the Town Hall about the " Rails/ Trails " proposal. This meeting is for the proposers to ask the Town to request a feasibility study. This would be the start of what may be a multi-year process to consider and perhaps implement this trail.

Justine announced that she would be having knee surgery and that Catherine had agreed to become interim chair of the Open Space Committee in her absence, probably only for the December and January meetings to be held the first Tuesday of each month.

There being no further business before the committee, and upon motion duly made and seconded, it was unanimously voted to adjourn at 8:52 P.M.
