

MINUTES OF MEETING
May 7, 2009

Meeting called to order at 7:00 p.m.

Jane Brace, Open Space Committee

Jane Brace came before the Board to discuss the Open Space Committee and what their part is in Town of Dover, Jane wanted the Board to know that their Committee does not only include land. They have other concerns as well; a list was distributed and Jane wanted to know what the Boards part would be on any of the question asked. Dr. Barbara Roth-Schechter explained that their will a Lyme Disease Sub Committee starting in May, Dr. Barbara Roth-Schechter will e-mail Minutes of the meeting to Jane Brace for Open Space Committee. We also handle the Mosquito Control Program. Jane was very concerned about the large amount of salt used on the Dover Roads in the winter, this would be controlled by the DPW and is needed for keeping the road clean. one of the other questions of concern was animal control Diane Fielding Admin. Director, informed Jane that the Board has a large Animal Control Officer, we also do A Rabies Clinic once a year along with the Septic System and well information these also go thru the Board of Health, along with a Mercury Control program and an Emergency Preparedness program. Jane Brace thanked the Board for all the information that they provided.

Charles River School above Ground Pool

David Dean from Charles River School appeared before the Board, to request that they be allowed to put up an above ground pool which will be 20' by 40' it will have cartridge filters and fence and gate which must be alarmed when pool is not in use. The Board approved the Pool upon Agent Angieri approval.

1 Betsy Lane

Agent Angieri explained that this is a continuation of a discussion from the last meeting regarding 1 Betsy Ln. where they want to use a heat pump well, we asked them to come back to see what the Board wanted to due about a policy using these heat pump wells. The Board was given information regarding the systems; these are approved by DEP Dr. Harvey George wanted to know if the Board would notified regarding the liquid being used in this system , Agent Angieri answered yes to the

question. Agent Josef Fryer recommended that the Board of Health waive regulation 813 on the well regulation for ground water heat pump systems so that wells will be cut down below grade. No chemicals, fluid, or substances be added without Board of Health approval. No permanent structure should be built within 10' of underground well, waterlines, or heat pump systems. As-built plans by registered engineer be on file with the Board of Health so that it shows where everything is, so when the plan goes to the Building inspector he will know not to grant a permit to build an addition with out checking with the Board of Health, also to include set backs of 50' from water supply, 50' from septic systems, and abandonment's of wells must be decommissioned as per Board of Health and under well regulations. Motion: Was made by Dr. Barbara Roth-Schechter to approve the guidelines as outlined on the ground water heat pumps for close lope heat pumps and as outlined and in accordance with the state guidelines and to be added to the well regulation Dr. Joseph Musto seconded the motion and it was unanimously approved by the Board on this date of May 7, 2009. Agent Angieri wanted some clarification on the charges for the heat pumps since some require more then one. The Board recommend that the first well fee will be \$475.00 and any additional wells needed will be \$375.00, and they all will be under one permit. and it was decided that a Motion should be made regarding the fees Motion: was made by Dr. Barbara Roth-Schechter and seconded by Dr. Joseph Musto.

Dr. Harvey George wanted to make a motion that after the May election, that Dr. Barbara Roth-Schechter take her place as Chair of the Dover Board of Health, Dr. Joseph Musto seconded and it was unanimously approved by the Board.
